

# Professional Towing Association of Ontario Tow Trade Show Exhibitor Agreement

## Professional Towing Association Responsibilities:

- Provide you with a written confirmation of your reservation
- All items that are included in the package that you have chosen

## Trade Show Exhibitor Responsibilities:

- Set up time: 9:00 am – 2:30 pm Friday September 12
- Take down time: 4:30 pm Saturday September 13
- Fill out appropriate paperwork
- Provide a copy of up to liability insurance coverage
- Complete set up (30 minutes) before designated event start time
- Cleaning of your event space during and after event i.e. garbage removal
- Provide own power (if required)
- **Exhibitor must stay until 4:30 pm, show close on Saturday**

## Terms of Payment:

That for the agreed use of said facilities; the Exhibitor shall pay the Professional Towing Association a **\$100.00 deposit** upon submitting the application and agreement. **Payment for the remainder in full for booth rental space must be made no later than June 28, 2025. Payments should be made out to the Provincial Towing Association of Ontario Inc. through cheque, credit card or e-transfer.** Refunds for cancellation of booth space are refundable up to June 21, 2025, however, there will be a 15% administration fee on all refunds. **Payments are non-refundable after June 21, 2025.** Receipts for payment will be provided at set up/registration on site at the PTAO Tow Trade Show.

## Terms of Use:

That the Exhibitor has received, as part of the rental package, the PTAO Tow Trade Show Application; Trade Show Exhibitor Agreement; Trade Show Information Sheet; Venue Rules and Regulations; and Sponsorship Information Sheet. The Lessee has read, understands, and agrees to all the terms and conditions listed. That all local, provincial, and federal laws, bylaws and regulations will be followed including but not limited to the Ontario Health and Safety Bylaws.

**INSURANCE INFORMATION**

The Exhibitor must attach a copy of Liability insurance certificate naming both Bingeman's and the Professional Towing Association of Ontario Inc.

The certificate should have the following information:

- Company name
- Policy #
- Minimum coverage of \$2,000,000.00
- Insurance company name and contact information
